#### **AWARE**

of the criminal penalties in the event of issuing untruthful declarations or indication of false/untruthful data,  
as referred to in art. 76 of the D.P.R. 445/2000

#### **I DECLARE**

Pursuant to art. 6, paragraph 2, of the "Regulation on the Tourist Tax" that I am entitled to the exemption for the following reasons,  
falling in one of the following cases:

1. non-self-sufficient disabled persons, with suitable medical certification, and their companion and parents who accompany differently abled minors;
2. members of law enforcement and military, as well as the national firefighting and civil protection corps who stay overnight for service reasons;
3. "volunteers" who provide their services in the social sector for events organized by the municipal, provincial, and regional administrations or for environmental emergencies;
4. those who stay in accommodation facilities following measures adopted by public authorities to deal with emergency situations resulting from calamitous or extraordinary events and for humanitarian relief purposes are also exempt from the tourist tax;
5. bus drivers and tourist guides who provide assistance to organized groups. The exemption applies for every bus driver and for every guide/accompanier for every 20 participants.
6. school groups on educational visits and their accompanying teachers, upon certification by the School Principal;
7. athletes belonging to sports groups participating in initiatives, retreats, competitions, and tournaments organized by local sports associations, upon certification by the relevant Sports Federation;
8. those staying for professional/work-related reasons subject to the issuance of a regular invoice and the delivery, by the interested party to the accommodation facility manager, of a specific self-declaration statement.
